## Fee schedule for calibration services by Manufacturer and EHS

(Please note that total shipping costs will vary, effecting total cost)

- (\*) these instruments normally need several isotope efficiencies with MDAs which incurs additional costs from standard factory calibration costs as follows:
  - MDA: \$50 per isotope
  - Efficiencies: \$15 per isotope (first two free as part of standard calibration)
  - Additional detectors: \$15 each (one detector with standard calibration)
- Factory labor charges range from \$100 to \$175/per hour. EHS labor charges do not exceed \$75/hour.
- Repairs and calibrations may vary, billing will reflect actual changes. Replacement of non-expendable parts will result in additional fees.
- If EHS is unable to calibrate a meter, it will not be sent out for factory calibration without owner approval.
